Greetings from AICTE to all education partners/ Institutions/ Universities!

You all may be aware by now that AICTE has been entrusted the responsibility of facilitating smooth conduct of various tests/ examinations conducted by National Testing Agency (NTA).

AICTE in collaboration with National Testing Agency (NTA) has already facilitated successful conduct of JEE Main 2023 (Session-I) and currently UGC (NET) exam is under progress. Thank you all for helping to organize these exams.

National Testing Agency (NTA) has already provided the calendar for major tests/examinations to be conducted by NTA during the first half of Academic year 2023-24. Common University Entrance Tests (CUET) 2023 is scheduled from 21<sup>st</sup> May to 31<sup>st</sup> May 2023 with reserved dates from 01<sup>st</sup> to 07<sup>th</sup> June 2023. CUET is an online computer based test (CBT) for admission to colleges/universities.

All education partners / Institutions/ Universities are called upon to support AICTE in this national duty of ensuring quality of higher education by submitting their willingness for the scheduled dates of CUET exams i.e. from 21<sup>st</sup> May to 31<sup>st</sup> May 2023 with reserved dates from 01<sup>st</sup> to 07<sup>th</sup> June 2023. **The education partners are advised to save these dates and advised not to enter into any arrangement/ agreement with any other agency on the CUET exam dates.** In this connection, a google form shall be shared shortly for submission of willingness by the education partners.
