Report on Anti-Ragging Sensitization Programorganized on Aug 30, 2024 at 4.00pm

Ragging has long been recognized as a serious social and academic menace that threatens the safety and well-being of students. To reaffirm its **zero-tolerance policy towards ragging** and to sensitize faculty about their responsibilities in preventing such incidents, **Kakatiya Institute of Technology & Science**, **Warangal (KITSW)** organized an **Anti-Ragging Addressing Programme** under the guidance of the Principal, **Prof. K. Ashoka Reddy**.

The session was specially convened for all faculty members — both teaching and non-teaching — to reinforce vigilance and ensure strict implementation of anti-ragging measures within the campus.

Proceedings of the Programme

In his address, **Prof. K. Ashoka Reddy** emphasized the **collective responsibility of faculty members** in maintaining a ragging-free campus. He called upon all staff to remain **vigilant** at all times and ensure that students, particularly freshers, feel safe, welcomed, and respected.

He directed the **Anti-Ragging Squad Faculty Team** to take their duties with utmost seriousness and to actively monitor student activities within hostels, classrooms, canteens, and other common areas. The following key instructions were highlighted during the session:

- Faculty should **be vigilant** and observant of student behavior.
- Every member must take responsibility for preventing ragging.
- **Registers must be maintained** with updated observations and preventive measures.

- Faculty and staff should **not be lenient** in addressing suspicious or unacceptable behavior.
- Any incident, however minor, should be **immediately reported to the authorities** without delay.

Prof. Reddy further displayed the **anti-ragging measures** available on the institute's official website, including:

- Institutional framework for anti-ragging vigilance
- Preventive steps and awareness campaigns
- Defined punishments for different levels of ragging behavior
- Past incidents and disciplinary actions taken by the institute

This transparency reinforced the seriousness with which the institute approaches the issue and ensured that faculty were fully aware of the rules, regulations, and consequences associated with ragging.

Emphasis on Responsibility

The Principal strongly reminded faculty that **prevention is more effective than cure** and that their proactive involvement is key to ensuring student safety. He urged them not only to enforce discipline but also to **mentor students positively**, creating an atmosphere where ragging finds no space.

The session concluded with a collective resolution by all faculty members to remain proactive and responsible in maintaining the **ragging-free environment** that KITS Warangal has always stood for.
